As a participant, we agree to:

- Rear the pheasants according to the procedures specified in the New York State Department of Environmental Conservation's Day-old Pheasant Chick Program Guide (Revised January 2004). For your convenience an electronic version of this document is available on the NYS Department of Environmental Conservation web site at: [http://www.dec.ny.gov/docs/wildlife\\_pdf/dayoldchicks.pdf](http://www.dec.ny.gov/docs/wildlife_pdf/dayoldchicks.pdf) or you may request a copy at the 4-H office.
- Have all facilities and equipment ready *prior* to the time indicated in the Day-old Pheasant Chick Program Guide. This includes having the brooding house ready *prior* to the arrival of the birds and the outdoor pen in place by the time the pheasants are 3 weeks of age.
- Pick up the pheasant chicks on the date designated in early May 2018 at the Cooperative Extension 4-H Office.
- Release the pheasants no earlier than eight (8) weeks of age, but not before AUGUST 1st on lands open to public pheasant hunting as specified by the NYS Department of Environmental Conservation. Pheasants must be released no later than the end of the pheasant-hunting season. **BIRDS MAY NOT BE RELEASED ON PRIVATE SHOOTING PRESERVES.**
- Allow a representative of Cornell Cooperative Extension and/or NYS DEC visit our site/facilities for inspection.
