K-12 Benchmarking 101

On April 15, 2010, from 2-3 PM EDT, EPA will host this webcast to teach attendees the basics of benchmarking K-12 buildings using EPA's Portfolio Manager tool. Portfolio Manager can help measure and track energy and water use across an entire portfolio of buildings. Buildings can earn an energy performance rating compared with peer facilities across the country, and top-performing buildings are eligible for national recognition.
